Salinas, CA – All interested candidates running for office in the June 5, 2018, Statewide Primary Election must file their signature in-lieu of filing fee petitions by Wednesday, February 7 at 5:00 p.m.

In addition, all candidates running for a Judicial Seat in said election must file their Declaration of Intention no later than Wednesday, February 7 at 5:00 p.m. **Judicial Candidates must pay their filing fee at the time they file their Declaration of Intention.**
