REPORT OF THE MANUAL TALLY CITY OF PACIFIC GROVE SPECIAL TAX MEASURE ELECTION SEPTEMBER 14, 2021

<u>1% Manual Tally of Paper Ballots:</u> The 1% manual tally is defined by Election Codes §336.5 as the public process of manually tallying votes in one percent of the vote by mail batches and polling place voting precincts selected at random by the elections official and one batch and precinct for each race not included in the random selections. This procedure is conducted during the official canvass to verify the accuracy of the automated count. This tally includes paper ballots cast at the polling place and by mail.

On Friday, April 15, 2022, Monterey County Elections emailed to interested parties and published the Public Observation Calendar informing the public of when and where the 1% manual tally was to take place. Additionally, a press release was also published on Thursday, April 15, 2022. Both the Observation Calendar and the press release were available on the Monterey County Elections website. Finally, a notice was placed on the Department's public bulletin board informing observers of the 1% manual tally activities and location.

On Wednesday, April 13, 2022, at 11:00 a.m., the Elections Department publicly randomly selected the following for the 1% manual tally per Elections Code §15360(2):

1% vote by mail batches.

• 1% of polling places

Vote by mail batches were selected using three 10-sided dice where the first die was used to select one of 3 tabulators (6, 7 or 8) and the remaining two was used to select the last 2 digits of 3-digit batch sequence number. (Within the batch range 001 - 023)

One of three polling places was selected using one 10-sided die.

The following batch was selected to achieve 1% of the vote my mail batches covering all contests:

• Tabulator 6, Batch 003

The following polling place was randomly selected to achieve 1% of all polling place covering all contests.

Pacific Grove Adult School, located at 1025 Lighthouse Ave, Pacific Grove, CA.

Results of the 1% Manual Tally of paper ballots: During the 1% manual tally, the Elections Department did not encounter any variances; confirming the accuracy of the results from the ImageCast[™] Central (ICC) paper ballot tabulating machines and adjudication machines. The 1% Manual Tally was completed at 2:00 p.m. on Monday, April 18, 2022.
